





Safety code review

- Clarify where requirements are mandatory or advisory
- Reduce any ambiguity
- Fully comply with the Traffic Signs Regulations and General Directions 2016 (TSRGD)
- Consistent with Inclusive Mobility, Transport Scotland's Cycling by Design, Active Travel Design and Active Travel Act guidance (gov.wales)
- Ensure upholds safety standards and enables works promoters to safely carry out SLG
- Ensure safety of all road user groups
- Identify where guidance applies to specific countries



Digital Traffic Regulation Orders (TROs)

- Clause 93 Automated Vehicles Bill
- Will give SOS power to make regulations to require any authority that makes TROs to send them digitally to a central publication platform
- Remaining Bill stages should be completed in May
- Plan to consult on draft regulations autumn 2024


Overview of Street Manager scope and release dates

Performance Based Inspections

- Fixed inspection units for 2023/24 and automating the moving up/down 5%
