The strategic context

- ▶ Data and digital have transformed other sectors benefiting customers through greater choice and ease of use.
- ▶ Opportunity for similar step-change in transport.
- ▶ SofS wants to “Make the UK one of the best places in the world do to transport digitally”.
- ▶ AI and data Industrial Strategy Grand Challenge.

Data (and digital connectivity) can unlock new opportunities

- ▶ Underpins a “total transport system”.
- ▶ New products and services, e.g. MaaS.
- ▶ Policy insights and helping ‘nudge’ behaviours.
- ▶ Improving planning, management and optimisation of transport networks.
- ▶ Predictive analytics.
- ▶ Data interoperability and integration with other systems.



Lack of data sharing is also impeding progress...

- ▶ Fears of breaching regulations around security and privacy.
- ▶ Skills.
- ▶ Cultural factors.
- ▶ Weak evidence base, including lack of transport-specific use cases.
- ▶ Lack of incentives.
- ▶ Uncertainty around data standards, formats, metadata etc

 - discovery, where gaps and guidance needed
 - set within emerging Data Strategy
 - focus on process of opening and sharing transport data
 - provide a business case for data exploitation
 - demonstrate good practice
- ▶ Working with TDI to consider training needs, procurement advice and building business case
- ▶ TDI Conference – Bristol 19 June



Building evidence base - local authority open data competition

- ▶ Competition set within Future of Mobility: Urban Strategy”
 - ▶ High quality – 11 schemes, nearly £1m
 - ▶ Parking and real-time traffic information
 - ▶ Collaborative, opening existing datasets, standards
 - ▶ Reporting, business cases, monitoring
- GovTech Challenge – potential £2m fund for using data for smarter traffic management(traffic congestion)

- ▶ C-ITS Research Pool – 26 funded projects
- ▶ C-ITS Focus Groups -26
- ▶ Based on Successful SPATULA Group
 - ▶ Group C-ITS Projects into four themes;
 - ▶ Smarter Parking

 - ▶ Connected Information and Technologies
 - ▶ Signal Phase and Timing (SPAT)
- ▶ The Transport Technology Forum (TTF)

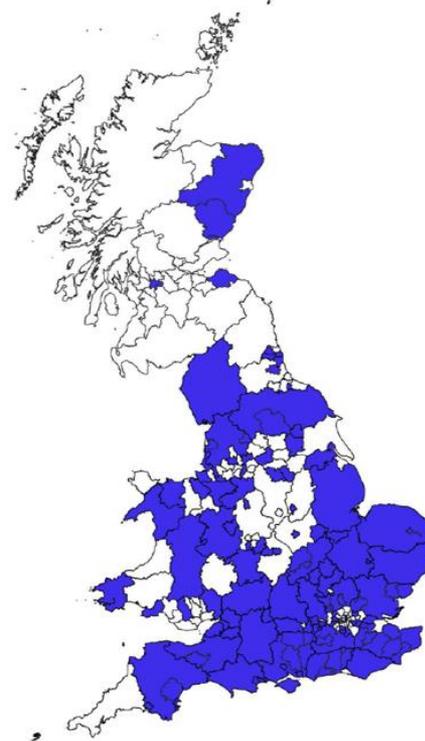
