

The following environmental management measures and projects have been completed or implemented since the 2019 baseline.

Review of travel guidance with a new policy focusing on making "green travel choices" In addition, staff are now encouraged to log all their travel days and highlighting the mode of travel as part of awareness in this area

Implementation of improved environmental criteria as part of internal procurement policy



Accreditation to Silver status by Groundwork UK.

Formal activity in this area began in 2022 with the formation of our Environment Group. During 2023 the group engaged the services of a third party organisation to support us in providing improved scope three measurements.

The proposed carbon reduction projects GeoPlace have planned in 2025 and beyond include

- Wide ranging staff engagement and information strategy including new guidance on our intranet, backed up by senior level promotion and engagement plus additional support and guidance around staff working from home
- Developing additional best practice on our capital goods purchasing
- Continue to work towards becoming a paperless organisation
- Further enhancing our environmental reporting and monitoring inline with best practice guidance from Groundwork
