



Questions you may want to ask

Will VOA still create addresses...

- Yes, in the short term, but in the longer term we want to move to be consumers of 'official' addresses.
- System has been set up to consume UPRNs.

Are all addresses 'official'...

- No but structure aligns with BS7666 which is key.
- Domestic system live. Still building the non-domestic system.

Has the change gone smoothly...

- No still a few 'bugs' and people need to get familiar with new processes.
- 100% believe we've done the right thing.

Does the BS7666 standard meet all of VOA's requirements for addressing?

- We value 'hereditaments'.
- Relationship to many-to-many.

Summary statement

The VOA are:

- Adopting and utilising the UPRN when referring to property-based information.
- Building UPRNs (and USRNs) into our systems.
- Moving towards being consumers of addresses not creating our own.

There is still a way to go, but we have taken the first steps to get there.
